NATIONAL INDUSTRIES DEVELOPMENT CO-OPERATIVE FEDERATION LTD.



1. NAME OF THE FEDERATION :

The name of the Federation shall be the NATIONAL INDUSTRIES DEVELOPMENT CO-OPERATIVE FEDERATION LTD., which shall be referred to hereinafter as 'FEDERATION' .

2. PRINCIPAL PLACE OF BUSINESS AND REGISTERED OFFICE :

The principal place of business & registered address of 'FEDERATION' shall be at A/P. Tursawan, Khairabad, Sitapur 261 001 (Uttar Pradesh). If any change in this address shall be intimated to the Central Registrar and all concerned within 15 days of it's change and also published in local newspaper and shall be made by an amendment of it's bye-laws after following the procedures laid down in Sec. 11 and Rule 8(2)of the Multi State Co-operative Societies Act, 2002.

3. AREA OF OPERATION :

The area of operation of 'FEDERATION' shall be the revenue territories of Andhra Pradesh, Uttar Pradesh, Uttarakhand, Bihar States. Thus it will comprise of Four adjoining States.

4. DEFINITIONS:

In these bye-laws unless there is anything repugnant to the subject or context—

1. 'ACT'	Means the Multi - State Co-operative Societies Act, 2002.
2. 'RULE'	Means Rule as provided under the Multi-State Co-operative Societies Rules, 2002.
3. 'CENTRAL REGISTRAR'	Means the Central Registrar of Multi-State Co-operative Societies appointed under the Multi-State Co-operative Societies Act, 2002
4. 'BYE-LAWS'	Means the bye-laws of 'FEDERATION' for the time in force which have been duly registered or deemed to have been registered under the Act and includes amendments





thereto which have been duly registered or deemed to have been registered.

5. 'DELEGATE'

Means a person who is duly appointed, elected by the 'FEDERATION' or part thereof in accordance with it's bye-laws as it's representatives to the General Body of the 'FEDERATION' or a person who is duly authorized by the Board of the member Society to represent the Society in General Body of the 'FEDERATION' of which the Society is a member.

6. 'GENERAL BODY'

Means all the member of 'FEDERATION' include a body constituted under the provisions of the Act.

7. 'BOARD'

Means the Board of Directors of the 'FEDERATION' constituted as per it's bye-laws.

8. 'GENERAL MEETING'

Means a Meeting of the General Body of 'FEDERATION' & includes Special General Meeting .

9. 'CHIEF EXECUTIVE'

Means the Managing Director of the 'FEDERATION' appointed under Section 51 of the MSCS Act, 2002.

10. 'PERSON'


Means an adult individual, proprietary concern, a partnership firm duly registered under the Indian Partnership Act, 1932, a Company or any other body corporate constituted under the law for the time being in force, a Society registered under the Trade Union Act, 1926. State Government and Public Trust registered under any law for the time being in force for registration of such trusts subject to amendment in the Act.

11. 'OFFICER'

Means a President, Vice-President, Chairman, Managing Director, Secretary, Manager, Member of a Board, Treasurer, Liquidator, An Administrator appointed




under Section 123 and includes any person empowered under this Act or the rules or the bye-laws to give directions in regard to the business of a 'FEDERATION'.



12. 'MEMBER'	Means a person joining in the application for the registration of the 'FEDERATION' and includes a person admitted to membership after such registration in accordance with provisions of Multi-State Co-op. Societies Act, Rules and Bye-law.
13. 'NOMINAL MEMBER'	Means a person who has been admitted as a nominal member under the bye-laws of the 'FEDERATION'.
14. 'MULTI-STATE CO-OP. SOCIETY'	Means a Society registered or deemed to be Registered under the Multi-State Co-op. Societies Act, 2002.
15. 'NATIONAL CO-OP. SOCIETY'	Means a Multi-State Co-operative Society Specified in the Second Schedule of the Multi-State Co-operative Societies Act, 2002.
16. 'FEDERAL CO-OP-ERATIVE'	Means a federation of Co-op. Societies registered under MSCS Act and whose membership is available only to a co-op. Society.
17. 'CO-OPERATIVE BANK'	Means a Multi-State Cooperative Society which undertakes banking business.
18. 'RESERVE BANK'	Means Reserve Bank of India constituted under the RBI Act, 1934 (2 of 1934)
19. 'DEPOSIT INSUR-ANCE CORPOR-ATION'	Means the Deposit Insurance and Credit Guarantee Corporation established under sec 3 of the deposit Insurance Corporation Act, 1961;
20. 'DEFALTER'	Means a member who has defaulted in payment of any kind of dues payable to the 'FEDERATION'.
21. 'CO-OPERATIVE YEAR'	Means the period from 1st April to 31st March.





22. 'AREA OF OPERATION' Means the area from which the persons are admitted as members.

23. 'CO-OP. PRINCIPLES' Means the Co-operative principles specified in the first Schedule of the MSCS Act, 2002.

24. 'CO-OP. SOCIETIES' Means a Society Registered or deemed to be Registered under any law relating to Co-op. Societies for the time being in force in any State or Union Territory.

25. 'FEDERATION' Means 'National Industries Development Co-operative Federation Ltd.'

26 'SUB COMMITTEE' Means the Sub - Committee of the 'FEDERATION' formed in accordance with provisions in the bye-laws and provisions of section 53 of Multi State Co-op. Societies Act, 2002.

27. 'NOTIFICATION' Means a notification published in the official Gazette

28. 'PRESCRIBED' Means prescribed by Rules.


5.0 OBJECTIVES :

The following are the objectives and functions of the 'FEDERATION'.

1. The principal object of the Federation will be to promote the interests of all its members to attain their social and economic betterment through self help and mutual aid in accordance with the co-operative principles viz. voluntary and open membership, democratic member control, member's economic participation, autonomy and independence, education, training and information, Co-operation among Co-operatives and concern for community.
2. To provide specialised training, education and data-base information.

To undertake research, evaluation and assist in preparation or perspective development plans for its member Societies.





4. To prepare model bye-laws and policies for consideration of its member societies.
5. To help member Societies to settle disputes among themselves.
6. To undertake business services on behalf of its member Societies.
7. To provide management development services to member Societies.
8. To evolve viability norms for member societies.
9. To provide legal aid and service to members societies.
10. To assist member societies in organizing self help
11. To develop market information systems, logo brand, promotion quality control and technology upgradation.
12. To study the current status of the presently closed down units, to seek expert advise, and identify the ways and means to restart such units.
13. To secure financial assistance for the newly starting units that have been cleared for feasibility by the experts.
14. To identify and seek out expert and skilled personnel, select them, train new skilled workers and supply them to member societies.
15. To attempt to secure special financial grants from organizations/ Institutions/ Government and to follow up for their fulfillment.
16. To keep the members informed of the changing policies of the Government.
17. To make available to the members upto date information about the domestic and global markets, so as to encourage import-export trade;
18. To undertake and rehabilitate sick industries as well as to establish new industries in the field of sugar industry, textile industry, agricultural equipments industries, Oil industries,





Plastic Industries, iron & steel industries, fiber & acrylic industry and all other industries.

19. To raise funds for its own business.
20. To arrange for construction of building necessary for business of the Federation and its members and also to take up the construction work of the other government/ institutional agencies.
21. To enter into collaboration with the Co-operative and others in India.
22. To guarantee the loans advanced or credit granted to member of the Federation by the Government, Bank or any other agency within such limits and such terms as may be fixed and charge commission thereon.
23. To do all things that may be incidental or conducive to the attainment of any or all the aforesaid objects or for the advancement of the Co-operative movement in general.

6) SERVICES PROVIDED TO ITS MEMBERS

- i) To provide specialised training, education and data-base information.
- ii) To provide model bye-laws and policies for consideration of it's member societies.
- iii) To provide management development services to member Societies.
- iv) To provide legal aid and service to members societies.
- v) To provide consultancy to rehabilitate sick units.
- vi) To provide skilled workers.
- vii) To provide consultancy for purchasing machinery of member Societies.
- viii) To provide educational training to it's member Societies.
